Thank you for applying for a kennel name. As a kennel name holder you will receive a number of UEKC benefits and services as part of your exclusive membership package.

### Kennel name

A kennel name is an exclusive word that is associated with you and your dogs. Known as your 'breeder signature', a kennel name will set your puppies aside from those of anyone else. You can include your kennel name within the names of your puppies at the point of registration as well as add to an existing name of a dog in your current registered ownership. Becoming a kennel name holder will also enable you to receive the puppy naming service free of charge.

### 1. Applicant and additional owners

All proposed holders of the kennel name should include their name on this application and all owners will be recorded and printed on any publications and documents relating to the kennel name. The applicant is the person who is applying for the kennel name either as the sole holder or in partnership with additional holders. The address stipulated on this application should be the address where the main holder resides. As such, any documentation will be sent directly to this address. In the case of joint ownership, you, as the applicant will act as the point of contact in regard to matters pertaining to The UEKC.

However, any additional owners will also be able view the kennel name subscription information if they sign up for an online account. Please note, in the case of joint ownership, any other joint owners of the kennel name must include their title, first name/initials, surname and unique email address in the additional owner section. The declaration must be signed by all proposed holders.

- ✓ A selection of three names should be given in order of preference.
- ✓ The applicant(s) cannot use his/her own surname.
- ✓ Common place names, Registered company and trade names cannot be used

Important: If you change your name, address or email address, The UEKC must be made aware of these changes. Failure to update your details may prevent important correspondence relating to your kennel name reaching you.

Please note that the subscription renewal for your kennel name will be due annually on the date the kennel name was first approved.

- An initial fee is payable to register a kennel name.
- The maintenance of the kennel name will be due for payment annually on the date the kennel name was granted. The UEKC will notify you six weeks before the subscription renewal payment is due, if paying by credit card or cheque. It is the responsibility of the kennel name holder to ensure payment is made by the due date.
- If the annual maintenance payment is not made the kennel name will lapse and will no longer be protected from being used in the naming of puppies
